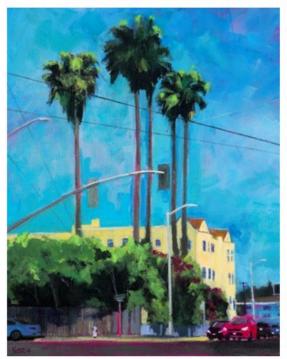

#### Reader's Guide

The Five-Year Capital Improvement Plan (CIP) is prepared by the County Administrator's Office (CAO) in close collaboration with the General Services Agency (GSA), the Public Works Agency (PWA), and the Community Development Agency (CDA).

The contents of the CIP are structured by department. The GSA Portfolio has been divided into several categories to delineate different project types. The projects captured in the FY 26-30 CIP represent projects that were presented to the Board of Supervisors between April 30, 2024-May 13, 2025. Projects can be introduced into the CIP throughout the fiscal year via board letter and are captured in each annual CIP update. The projects and their associated funding amounts for FY 25-26 represent a mixture of previously approved project funding as well as anticipated funding approvals. Projects with anticipated funding approvals are noted throughout the document.

<u>Category I - Projects Approved and Underway:</u> This category represents active construction and development projects managed by the GSA.

<u>Category II - Santa Rita Jail Projects:</u> This section outlines the various project scopes related to the Santa Rita Jail facility located in Dublin.

<u>Category III - Facility Condition Assessment, Americans with Disabilities Act (ADA), and Environmental (Including Hazardous Materials Abatement) Projects:</u> This category includes a range of activities including facility upgrades, asset maintenance efforts, infrastructure improvements, solar and energy efficiency projects and the specialized projects and requirements of federal, State, and local regulations including facility access, health and safety and environmental requirements. These figures do not include seismic retrofit costs nor the annual cost of daily routine maintenance operations, including preventative and corrective maintenance activities for County-owned facilities. Deferred maintenance needs associated with Santa Rita Jail are included in Category II.

<u>Category IV - GSA Pending Projects - Studies Underway:</u> The projects included here are in the process of evaluation, planning, and further development. The Board has authorized some expenditures for this research and preliminary planning, but a complete project development plan has not been created or approved.

<u>Category V - GSA Completed Projects:</u> This category provides details regarding recently completed or closed projects. Please find the details for these projects in the Appendix.

<u>Category VI - GSA Future Projects:</u> Projects in Category VI are in the pre-development phase and are either undergoing a feasibility analysis (Category IV), scope development, cost estimating and/or fund development stages. These projects are re-evaluated upon the completion of the above-mentioned stages and often Board Committee review is requested as part of the pre-development process prior to full Board review and decision-making. Project budgets as described in this category represent conceptual budget estimates, based upon labor and materials pricing at the point of initial project conception/feasibility development. These estimates are updated as the project evaluation progresses. The fact that the County has not yet identified funding is not necessarily a reflection of the necessity or even the urgency of these portfolio investments. Projects that appear in this category are not approved until the Board of Supervisors takes formal action to move the project status to Category IV or Category I.

#### **Public Works Capital Program**

This section sets out the major capital project areas administered by the Public Works Agency, namely Flood Control and Road projects, whose budgets and scopes have been approved by the Board of Supervisors.

#### **Tier One Projects**



As part of the Fiscal Year 2012-13 Budget adoption, the Board established policies regarding the property tax increment returned to the County due to the February 1, 2012, statewide dissolution of redevelopment agencies, including the allocation of up to \$18M annually for up to five years for Board-approved priority capital projects in Unincorporated County (Tier One Projects) to be completed by the Community Development Agency (CDA), General Services Agency (GSA) or the Public Works Agency (PWA). The projects presented in the FY 26-30 CIP are the remaining active projects.

## Five-Year Capital Improvement Plan (CIP)

Established in 1853, Alameda County is the arm of local government that provides for the basic needs of vulnerable populations and for countywide health, human services, and public safety. At 821 square miles, Alameda County encompasses a varied urban, suburban, and rural geography with a total population estimated to be 1.65 million according to the most recent U.S. Census Bureau American Community Survey 5-year Data at the time of publication.

The County is governed by a five-member Board of Supervisors elected by district popular vote. The Board of Supervisors is responsible for providing policy direction, approving the County budget, and representing the County in several areas including unincorporated areas and dependent special districts.

For the County to effectively carry out its mission to provide services, it relies on a workforce of over 10,000 employees who deliver a myriad of services to the public in various buildings and facilities. This includes office buildings where families can apply for assistance through the Social Services Agency, seek medical treatment at Wilma Chan Highland Hospital, or visit a County library and get help with homework.

The County's Five-Year Capital Improvement Plan (CIP) is a programming document that outlines the County's plan for maintaining its physical infrastructure which includes traditional buildings but also, roads, trails, bridges, and flood control infrastructure. The CIP supports the overall goals of the County and is updated annually as part of the budget process. The first year of the CIP represents funds that are anticipated to be appropriated during Fiscal Year 25-26 by the Board of Supervisors. Years two through five of the CIP serve as a guide for long-term investments in the County's physical assets.

The CIP is funded with various revenue sources including but not limited to State and federal aid, County General Fund, Road Fund, Flood Fund, and taxes through voter-supported measures.

#### **CIP Structure**

The CIP is prepared by the County Administrator's Office (CAO) in close collaboration with the General Services Agency (GSA), the Public Works Agency (PWA), and the Community Development Agency (CDA).

The CAO provides several mandated services including developing and managing the annual countywide budget. The CAO's mission is to provide professional, innovative, and proactive leadership to the Board of Supervisors, Agency/Department Heads, and the public through responsible fiscal and administrative policy development and program oversight. All bond issuances are managed by the CAO.

GSA serves as the construction project manager and asset manager for the majority of County departments. Their mission is to provide Alameda County with quality and innovative logistical support. The GSA portfolio includes owned and leased buildings which they manage on behalf of their client departments. See the Appendix for more information.

Currently, GSA plans and performs capital improvement projects through three divisions: the Capital Planning Division, Capital Projects Division, and the Building Operations and Maintenance Division. The Capital Planning Division is responsible for long range strategic planning, development of new projects, and management of leased facilities. The Capital Projects Division houses a team of project managers who work on large-scale capital construction projects which are typically bid out to third party contractors. The Building Operations and Maintenance Division handles smaller capital projects which include major maintenance projects such as the replacement of roofs and boilers in County owned facilities. GSA is also responsible for the implementation of Category III projects including the Americans with Disability Act (ADA) projects, Sustainable Energy Projects, and Environmental Remediation Projects including hazardous materials abatement.

GSA organizes their capital projects into the following categories:

Category I-Projects Approved and Underway

Category II-Santa Rita Jail Projects

Category III-Facility Conditions Assessment, Americans with Disabilities Act (ADA) and Environmental (Hazardous Materials Abatement) Projects

Category IV-Pending Projects-Studies Underway

Category V-Completed Projects

Category VI-Future Projects

PWA is a separate County agency responsible for design and construction of multi-modal transportation facilities, street reconstruction and rehabilitation projects, and construction and rehabilitation of flood control facilities. Their mission is to enhance the quality of life for the people of Alameda County by providing safe, well-maintained, and lasting public works infrastructure through accessible, responsive, and effective services.

CDA is responsible for some of the former Redevelopment Agency's Tier One Projects and the Surplus Property Authority. In June of 2012, the Board adopted policies regarding the property tax increment adjustments resulting from the statewide dissolution of redevelopment agencies (RDA). These policies included the allocation of up to \$18 million annually for up to five years to fund up to \$90 million for twelve Board-approved priority capital projects in the unincorporated areas of the County, now referred to as Tier One Projects.

The Surplus Property Development Program is also included under the activities of the Capital Projects Program but not covered within the CIP. Under the supervision of CDA and GSA, the Surplus Property Development Program directs and



oversees the sale and development of the County's surplus real property assets to ensure they are converted to useful purposes and provide future revenue streams to help fund the County's Capital Program.

#### CIP Guidelines

As defined in this CIP, a capital improvement is a physical betterment or project involving facilities, land, or equipment, to increase the useful life by at least 10 years with a cost of \$100,000 or more. Items classified as capital improvements include:

- New buildings (including equipment needed to operate such buildings);
- Alterations, additions, or improvements to existing buildings;
- Land improvements, acquisition, and development;
- Equipment purchases with a total cost of \$100,000 or more and a useful life of at least 10 years; and
- Long-range planning and feasibility studies required before any of the preceding public facility improvements, or equipment purchases can be undertaken.

Over the years, the Board has adopted several policies that have provided guidance on financial management processes and practices of the County. The most recent amendment took place in December 2022 and the Capital Investment and Improvement Policies enumerated from that document are listed below:

- The County will maintain a comprehensive capital improvements program that is updated each year;
- The County will base all capital improvements on the County's long-term needs in order to minimize future maintenance and replacement costs;
- The County will coordinate the prioritization and phase of capital improvements with anticipated budget position and debt capacity;
- The County will estimate and consider future maintenance needs for all new equipment and capital facilities prior to deciding to proceed with the project;
- The County will identify the funding source for each capital improvement prior to deciding to proceed with the project. Intergovernmental and other offsetting sources will be sought out and used as available to assist in financing capital improvements;
- The County will provide for the maintenance of capital assets and equipment in the annual budget.

#### CIP Criteria

The allocation of capital improvement funding will take into consideration the order of priority criteria outlined below:

- 1. Enhance protection of public health and/or safety;
- 2. Ensure compliance with State and/or federal law or administrative regulations;
- 3. Reduce and/or stabilize operating budget costs;
- 4. Prolong the functional life of a capital asset of the County by 10 years or more;
- 5. Improve the ability of the County to deliver services;
- 6. Community support;
- 7. Availability of funding and funding type;
- 8. Leveraging opportunities;
- 9. Life cycle or maintenance impacts;
- 10. Staffing and resource availability;
- 11. Risk reduction and avoidance; and
- 12. Legal mandates.

#### FY 26-30 CIP Summary

The Capital Improvement Plan (CIP) is a five-year plan which identifies the long-range capital funding needs to support County programs. The County Administrator updates the Five-Year Plan each fiscal year to reflect the completion of Board-approved projects and the addition of new projects approved by the Board mid-year. The Plan also documents the unfunded need for additional capital improvements and new capital infrastructure requested by County agencies and departments.

The FY 26-30 Five-Year Capital Improvement Plan (CIP) outlines \$2.978 billion in expenses in FY 26-30 to develop and maintain the County's capital assets. GSA has the largest portfolio of work at an estimated \$1.896 billion in FY 26-30. PWA has the second-largest portfolio of capital work, comprised of road and flood projects of \$1.059 billion during the five-year plan. Lastly, CDA is managing the remaining Tier One funds of roughly \$23 million including the \$13 million of unallocated funds.

Total CIP costs are offset with revenue of \$2.154 billion during FY 26-30 leaving a funding gap of \$824 million. Although a funding gap is shown for PWA in the 26-30 CIP, PWA shifts eligible funding depending on State and federal resources and any shortfall will be covered within their Road or Flood Funds. On August 1, 2023, your Board approved the Long-Range Capital Financing Plan to help cover the funding gap associated with the General Services Agency (GSA) portfolio of projects. The FY 26-30 CIP incorporates the Long-Range Capital Financing Plan into its revenue assumptions, leaving a funding gap of \$711 million for GSA projects. The revenue assumed in the FY 26-30 CIP is contingent upon market conditions, a stable, strong economy and continued support of the Board's adopted Long Range Capital Financing Plan.

#### One Year Plan - FY 25-26

The Five-Year CIP serves as the County's roadmap for future infrastructure and capital improvement projects. The CIP document is refreshed annually as part of the budget process and the first year of the plan illustrates the immediate activity most likely to occur in the upcoming fiscal year and aligns with the Adopted FY 25-26 operating budget. The FY 26-30 CIP does not include the appropriations related to the Surplus Property Authority.

This section highlights the first year of the plan. The CIP anticipates roughly \$700 million in project costs for FY 25-26, with \$544 million attributable to GSA, \$154 million attributable to PWA and \$2 million attributable to CDA Tier One projects.

#### FY26 Total Funding Requested by Source



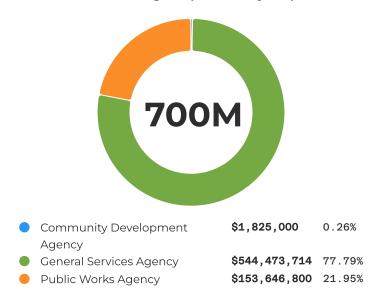

#### FY 25-26 Funding Plan

Of the \$544 million slated for the upcoming fiscal year under GSA, approximately \$9 million is attributable to Category I Projects. Many of these projects are smaller in scope and size and began construction in prior years. Most of the projects under Category I are funded by Federal, State and Local sources held by the specific client department. Therefore, in many instances, the funding associated with these projects represents only a small portion of the total cost and/or is the spending authority (appropriations) needed prior to the availability of the fund balance adjustment. Please see Capital Projects section for more information on projects.

In 2018, the Board approved GSA's procurement of a Facility Conditions Assessment, a comprehensive report that outlines the physical condition of a building including its infrastructure, systems and finishes to determine and prioritize recommendations to address these deficiencies. Using this information GSA prioritized projects with a focus on buildings that provide a critical service, high level of public usage, the uniqueness of the program/service provided and the availability of funding. What emerged was an overall plan for the projects at Santa Rita Jail (Category II) totaling approximately \$298 million and approximately \$168 million to address health care and Alameda Health System (AHS) buildings under Category III. Category II and Category III projects are funded by the Special Capital Construction Fund.

In addition, the Alameda County Fire Department issued \$70 million for the Measure X bond on July 16, 2025, and those appropriations are included (under GSA Category VI) in the CIP as well.

For PWA, in FY 25-26, approximately \$82 million is set aside to address flood projects, and \$72 million to address road projects. Please see Capital Projects section for more information on projects.

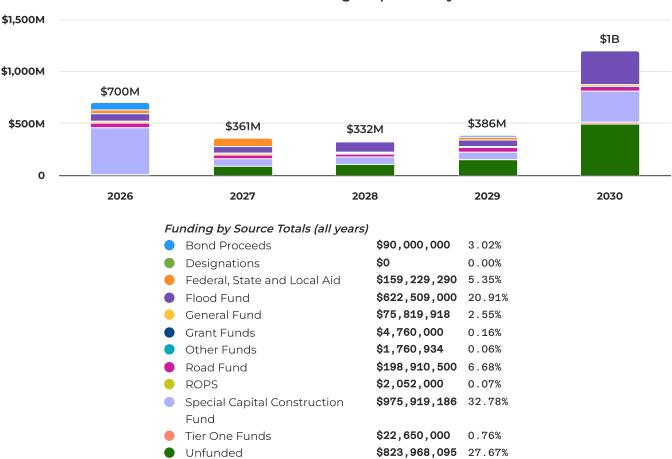

#### Multi-Year Plan FY 26-30

The FY 26-30 CIP represents nearly 100 projects and a total cost estimate of approximately \$3 billion, with \$2.1 billion of identified funding and approximately \$824 million of funding needs. The funding plan reflects currently available cost estimates, market conditions, and forecasted needs which are subject to change. The funding plan utilizes a variety of revenues such as State aid, federal aid, and County General Fund, as detailed in the program components below.

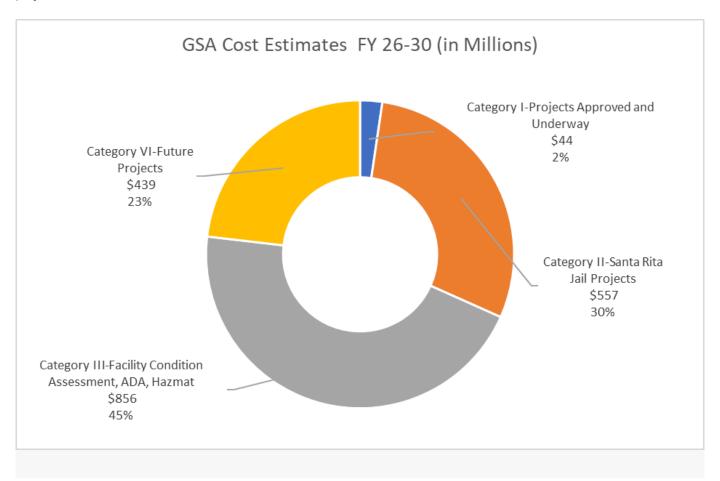




## General Services Agency (GSA) Projects

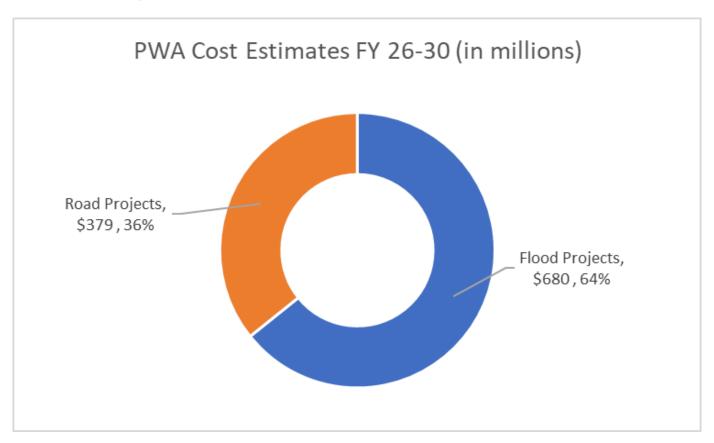
The department with the largest capital portfolio is GSA. The total project cost estimate is approximately \$1,896 million with a funding gap of \$711 million from FY 26-30. The GSA totals reflected in the CIP represent the current cost estimates and are subject to change. The funding to pay for these projects comes from a variety of sources, including but not limited to, bond proceeds, County funds, federal, State, and other government funding.

Under Category III, Facility Conditions Assessment, approximately \$42.8 million was committed in prior years to address the General Government, Alameda County Health operated buildings using American Rescue Plan Act Funds. In addition, \$15 million is set aside annually for major maintenance, Americans with Disabilities Act and hazardous material abatement projects for a total of \$75 million in FY 26-30.



## Public Works Agency (PWA) Projects

Over the next five fiscal years, PWA anticipates working on public works projects with an estimated cost of \$1,059 million. Of the total development costs, approximately \$946 million has been identified with \$113 million still pending. In FY 25-26 specifically, PWA has project plans of \$154 million, with 100% funding identified. PWA projects are highly leveraged using various sources with no net county cost contribution. Any gap in the Five-Year plan will be addressed with State, federal, Road, or Flood funds by the time construction commences.



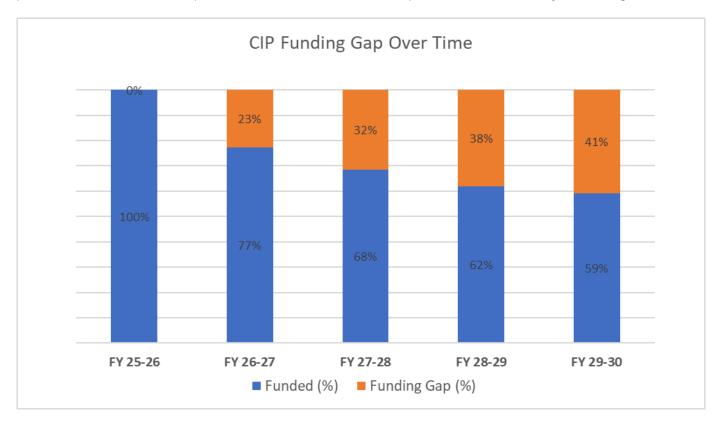
## Tier One Funding

As of the publication of this document, seven Tier One Projects have been completed, two are underway (Lorenzo Theater and Mission Blvd Phase 3), and one has not started (Eden Township Substation Replacement). Of the \$90 million allocation, \$72 million has been spent or committed, \$5 million reallocated to non-Tier One projects, and approximately \$13 million is being considered for White Cotton Cottage. Please see Tier One section for more information.

#### Pending Factors

Infrastructure and capital projects, including facility maintenance, are ongoing funding concerns. As noted in prior sections, the CIP illustrates \$3 billion in costs with only \$2.1 billion in identified revenue, leaving a funding gap of over \$800 million for all years, including future projects. Not only is funding a concern, but the volatility in the construction market will likely continue to drive up costs. The construction industry has been affected by changes in international trade policies and tariffs. These shifts are impacting the price of materials, supply chain timelines and overall project budgets. Unlike prior tariffs, recent policies have affected multiple trades and created an environment where construction bids are valid for shorter amounts of time.

Given the budget uncertainty related to state and federal funds and policies, and overall economic conditions, the figures presented in this CIP are the department's best cost estimates at this point in time, and are subject to change.



## Long Range Capital Financing Plan

On August 1, 2023, the Board approved the long-range capital financing plan to address the issues identified in the Facility Condition Assessment reports and to close the funding gap associated with the GSA capital portfolio. At the time, the FY 24-28 CIP presented a funding gap of roughly \$1.3 billion for GSA projects. Tier One Projects are fully funded by a designation, and the Public Works Agency projects' estimated funding gap is expected to be fully funded by future Road and Flood district revenues, therefore the Long Range Financing Plan was intended only to cover the gap associated with the GSA portfolio.

For the GSA portfolio, the FY 26-30 CIP highlights roughly \$1,896 million in expenses to develop and maintain the County's capital assets over the next five fiscal years and beyond. Because of the long-range capital financing plan, the CIP also identifies \$1,185 million in revenues to finance these projects, leaving a funding gap of \$711 million in the GSA portfolio. Funding anticipated in the Special Capital Construction Fund is comprised of a combination of sources. These amounts may fluctuate depending on market conditions, the stability of the economy, and the Board's continued support of the Long-Range Capital Financing Plan and any shortfall will create a larger future funding gap.

#### **General Services Agency (GSA) Projects**

The department with the largest capital portfolio is GSA. The total project cost estimate is approximately \$1,896 million with a funding gap of \$711 million from FY 26-30. The GSA totals reflected in the CIP represent the current cost estimates and are subject to change. The funding to pay for these projects comes from a variety of sources, including but not limited to, bond proceeds, County funds, federal, State, and other government funding.

#### **Public Works Agency (PWA) Projects**

Over the next five fiscal years, PWA anticipates working on public works projects with an estimated cost of \$1,059 million. Of the total development costs, approximately \$946 million has been identified with \$113 million still pending. In FY 25-26 specifically, PWA has project plans of \$154 million, with 100% funding identified. PWA projects are highly leveraged using various sources with no net county cost contribution.

#### **Tier One Projects**

As part of the Fiscal Year 2012-13 Budget adoption, the Board established policies regarding the property tax increment returned to the County due to the February 1, 2012, statewide dissolution of redevelopment agencies including the allocation of up to \$18M annually for up to five years for Board-approved priority capital projects in Unincorporated County (Tier One Projects) to be completed by the Community Development Agency (CDA) or the Public Works Agency (PWA).

## Category I (CAT I) - GSA Projects Approved and Underway

These projects have been reviewed, funded, and approved by the Board and are currently in active design, development, construction, or in post-construction closeout stage. Category I projects are managed by the General Services Agency (GSA). Please note, the project information pages contained in the Capital Improvement Plan (CIP) represent the current working budget and status updates at a specific point in time. The CIP is a living document that gets amended throughout the Fiscal Year as the Board amends the CIP to reflect adjustments in project costs, funding, and timelines. The costs projected in the Five-Year CIP are meant to illustrate anticipated spending authority (appropriations) during FY 26-30. Please refer to project information sheets in the Capital Projects Chapter for more information.



## Category II (CAT II)- GSA Santa Rita Jail Projects

Santa Rita Jail was built in 1988 and is located at 5325 Broder Boulevard in Dublin. The campus includes a central building, housing units, service building, and a warehouse. As the County's largest, 24-hour facility, capital planning surrounding its upkeep and maintenance is extremely important.

Consent Decree Projects: February 2022, the United States District Court for the Northern District of California approved a consent decree which outlines specific conditions in the jail which the County agreed to improve. This has resulted in the development of various consent decree-related capital improvement projects.

This section focuses on the multitude of capital projects both inside the jail and on the jail's campus which are in various stages of development. The projects can be categorized into the following scopes:

Accessibility Project: The County is making accessibility improvements as stipulated in the Settlement Agreement in the Legal Services for Prisoner, et. al. v. Ahern, et. al., Superior Court of California, County of Alameda, Case RG12656266. Accessibility improvements are scheduled to be completed in Summer 2026. The project funding was secured in prior years and encumbered on contracts which explains why the CIP does not show very much activity in the outyears of the plan.

**Network Infrastructure and Security Systems Upgrade Project:** The campus-wide Security Systems Upgrade project includes the replacement of the outdated security system which will include a fully integrated security control and monitoring system, expanded central control, and dedicated fiber optic backbone. The security upgrades are scheduled to be completed in Spring 2027. The project funding was secured in prior years and encumbered on contracts which explains why the CIP does not show very much activity in the outyears of the plan.

#### SRJ Space Programs and Services: Projects underway include:

- a. The Enhanced Outdoor Reconfiguration and Recreation Yards Project consists of the creation of new outdoor recreation spaces and updates to two existing quasi-yards.
- b. The Housing Unit Treatment Pod Project will provide ready-to-use confidential treatment spaces in the Housing Units for Behavioral Health staff to treat their clients.
- c. Santa Rita Jail ACSO and BHCS Staff Space Project will renovate space in the Core Building and Housing Units to provide office and treatment spaces for ACSO and BHCS staff.
- d. The Safety Enhancements Project will enhance the safety of the jail by removing potential ligature points in the housing units including those identified on bunk beds, cell desks, stools, ladders, shower heads, bubblers, and doorknobs. This project will also include the replacement of locks in three housing units and the administration area.

Two projects, Cell Softening and Security Screens are complete. The previously identified Mental Health Program and Services Unit (MHPSU) Project, which would have utilized state bond financing, is no longer being pursued.

**Facility Operations**: GSA in coordination with ACSO, has identified a number of projects to address safety and functional issues including:

- a. Kitchen Renovation including:
  - i. Replacement of outdated equipment operating beyond the expected useful life and reconfiguration of the kitchen layout for improved functionality.
  - ii. Demolition of the existing kitchen interior, including all furnishings, fixtures and equipment, as well as the demolition of any underground utilities, plumbing, interior finishes, demising walls and other interior elements not structural or supporting critical building functions.

- iii. Removal of the roof and replacement of the building management system, security system and fire-life safety system will be upgraded.
- b. Critical Operations Project, including:
  - i. Two 1500kVA 12KV generators will be replaced, and associated electrical system infrastructure upgrades will be made.
  - ii. A new one-million-gallon steel above-ground water tank will be installed, along with a second 12-inch water main for redundancy.
  - iii. The building management systems will be fully replaced, including Honeywell XC Classic controllers and FS-90 fire panels.
  - iv. Fire-life safety systems will be upgraded, including fire alarms, sprinklers, cybersecurity, telecom/low voltage, audio, and security radio systems. The security electronics system will be replaced with a new non-proprietary system to improve remote door control, intercom, building perimeter, duress system alarm monitoring, and CCTV surveillance.
  - v. One hundred and twenty-three commercial-grade doors will be replaced with detention-grade doors and hardware across several housing units (HU). Additionally, nine detention-grade sliding doors will be replaced in numerous areas within the facility.
  - vi. The HVAC (heating, ventilation, and air conditioning) system will undergo insulation removal and reapplication in fan enclosures of each HU and the core buildings, along with basic maintenance. Any unserviceable HVAC equipment or inaccessible ductwork will be replaced or cleaned as necessary.
  - vii. The interior Ring Road around the perimeter of the Housing Units, within the secure perimeter of the facility, will be replaced.
  - viii. The roofs of multiple housing units will be replaced with new insulation, roofing membranes, and flashings, and photovoltaic panels on one unit will be removed and reinstalled.

Additional projects will be identified in the upcoming fiscal year with the assistance of construction management firms following completion of the SRJ Master Plan and these costs will fall under the categories of Program Management and Future Facility Needs. The projects will be moved forward for Board consideration upon completion of the studies and the amounts below represent current estimates.

## CAT III- Facility Conditions Assessment (FCA)

The first step in creating a comprehensive Capital Improvement Plan is to have an understanding of the current condition of the facilities and infrastructure in the portfolio. A FCA is an industry-wide reporting tool provided by third-party consultants to real estate owners such as government entities. The County commissioned an FCA in 2018.

GSA developed bundled, shovel-ready project plans for priority facilities totaling approximately \$191 million in costs. The criteria used in the prioritization of projects includes the critical nature of the service, level of public use, uniqueness of program service and availability of funding.

Separate, but related to this scope, GSA is also actively managing energy savings projects Countywide, including the Fairmont Campus, Hayward buildings, and Veteran's buildings. These scopes include the installation of solar systems, energy-efficient building infrastructure and electric vehicle charging stations.

## Category V (CAT V)-Completed Projects

The following projects were completed and closed out since the last publication of the FY 25-29 Capital Improvement Plan. The project costs related to this category do not appear in the FY 26-30 Five-Year Plan.

#### JJC Exterior Equipment Project

The Alameda County Probation Department (ACPD) Outdoor Recreation Enhancements for the Youth Physical Activities project involved the construction of exterior exercise equipment. This project was included in planned, critical improvements to the Alameda County Juvenile Justice Center (JJC), which houses the ACPD Juvenile Hall.

In order to create a secure rehabilitation program that meets the specific and individualized needs of the youth and young adults previously housed at the Department of Juvenile Justice, ACPD sought to create a therapeutic housing environment that includes both indoor and outdoor activity areas for youth and their families to utilize. These improvements were essential to create a mentally, physically, and spiritually rehabilitative space for returning minors (youth under 18) and young adults.

#### Franklin Street Parking Fence

The parking lot located at 1424 Franklin Street, Oakland, also known as the Franklin Street Parking Lot, is maintained by the General Services Agency (GSA) and operated by the GSA-Parking Division.

GSA-Parking Division strives to ensure County parking lots are safe and secure. To enhance the security and safety of this parking lot, GSA determined that the existing fence and gate required replacement. The scope of work for this project included the removal and disposal of the existing chain link fence, installation of a new 10-foot high ornamental iron fence, swing gate, rolling gate, gate operator, and replacement of the existing electrical panel.

# Ashland Youth Center Furniture and Audio Visual Upgrades

The REACH Ashland Youth Center, located at 16335 E 14th Street in San Leandro, is a County owned facility that is operated by the Alameda County Health's (ACH) Center for Healthy Schools and Community (CHSC) and is maintained by the General Services Agency (GSA). Funds from the remaining balance of the original construction budget for the Ashland Youth Center Furniture and AV Upgrade (Project) were approved for improvements and upgrades to the front desk, camera, security access controls, furniture, and audiovisual (AV) equipment.

GSA and ACH updated the AV system components needed to provide functionality that will better serve our community. These systems were separated into 6 independent zones: 1) Front entrance lobby, 2) Groove dance center, 3) Lift workout room, 4) Media center, 5) the Fuente Wellness Center, and 6) the Bite Café. Each location was designed to be standalone, allowing users to easily connect and control sources, with volume, control selection and room functions available on a local touch screen panel. The upgrade included a new desktop computer for AV system troubleshooting and a 24-port network switch and router.

#### Dublin Transit Center Parking Garage

The Dublin Transit Center Parking Garage is an approximately 159,000 square foot, five- level structure with over 500 parking spaces and preferred spaces for vanpool vehicles and electric vehicle (EV) charging stations. In January 2018, the Livermore Amador Valley Transit Authority (LAVTA), as the lead agency, and the General Services Agency (GSA) sought grant funding from the California Department of Transportation (Caltrans) 2018 Transit and Intercity Rail Capital Program (TIRCP) to build a new parking garage structure. The site is on the Surplus Property Authority's Site D-1, a 2.4-acre parcel adjacent to the East Dublin-Pleasanton Bay Area Rapid Transit (BART) station parking structure.

The parking garage achieved ParkSmart Bronze certification, reflecting the County's commitment to environmentally responsible construction and reducing the carbon footprint by promoting sustainable practices in urban infrastructure.

# ROV Observation Space and Equipment Installation

The County of Alameda's property at 1221 Oak Street, Oakland, houses several departments including the Registrar of Voters (ROV). The scope of the ROV Observation Space and Equipment Installation Project (Project) was to provide election security and assist in the processing of materials sent to over 938,000 registered voters.

Federal and state-mandated operations for the Project included: accommodating the increased voter population before the March 2024 Presidential Primary Election to reach 1,000,000 in Alameda County, which also increased the need for staffing and workspace in ROV. The remodel consisted of creating a secure observation area for processing ballots by reconfiguring walls and installing new equipment to sort ballots as well as the associated HVAC, electric, and structural infrastructure to support the new observation area and equipment.

The Enterprise Fence Replacement involved replacing the existing chain link fence at 8477 Enterprise Way, Oakland, with a more secure wrought iron fence at the request of the Social Services Agency (SSA), which operates the facility. This upgrade enhanced the facility's security for SSA staff.

# San Lorenzo Audio Visual Upgrade

The San Lorenzo Library, located at 395 Paseo Grande, San Lorenzo, is a County-owned facility operated by the Alameda County Library and maintained by the General Services Agency (GSA). The Alameda County Library requested GSA to upgrade the audiovisual system at the San Lorenzo Library. The existing system was comprised of different components that were not working together properly. The San Lorenzo Library Audio Visual Upgrade (Project) provided a comprehensive upgrade to the audiovisual system.

The scope of work included the replacement and installation of a new audiovisual system, including the connecting of all necessary cabling and electrical to the existing announcement system. The Project improved the facility to optimize the use of video conferencing and delivered the commitment to meet the changing needs and interests of the Alameda County Library.

# Category VI (CAT VI)-Future Projects

Projects in Category VI are re-evaluated upon the completion of preliminary studies (Category IV), as well as when a completed funding plan has been identified. It is important to identify these future, pending projects so that the Board has an understanding of the financial impacts these projects could have on the County's budget.

Project budgets as described in this Category represent preliminary, conceptual estimates, based upon labor and materials pricing at the point of initial project budget development. As funding is identified, the CIP is amended, and projects are presented to the Board for approval. Board Committee review may be requested as part of the development process prior to final Board review and decision. Some projects are listed without project estimates but are presented in this list so that the Board has a full understanding of the potential projects in the pipeline.

# Public Works Agency Capital Projects

The mission of the Public Works Agency is to enhance the quality of life for people of Alameda County by providing a safe well maintained and lasting public works infrastructure. This is effectuated through the agency of capital improvement program plan. This section lays out the annual update to this program plan.

Public Works Agency infrastructure capital improvement program is a five-year plan for preserving and enhancing Alameda County's public infrastructure transportation and flood control facilities. Generally, it is designed to identify and prioritize infrastructure projects including tentative schedules and funding options. Infrastructure improvement projects entail the provision and major improvements to public infrastructure including the design and construction of multimodal transportation facilities, street reconstruction and rehabilitation projects and construction and rehabilitation of flood control facilities.

The process of developing the CIP begins with the preparation of a list of potential projects. These projects are generally identified through feasibility safety or watershed studies. Projects can also be identified by residents and other stakeholders for inclusion in the plan. Examples of these include:

<u>Pavement Management Projects</u>: These projects are identified and prioritized using a pavement management program by which pavement conditions are rated using a computer application. Each street is assigned a pavement rating or pavement condition index ranging from zero to 100. Depending on these ratings staff develops priority listing of streets and associated corrective measures for inclusion in the CIP.

<u>Sidewalk Improvement Projects</u>: these projects are identified and assigned a rating based upon a numeric scale developed as part of the sidewalk improvement program. From this scale, sidewalk projects are prioritized for inclusion in the CIP.

<u>Safety Studies</u>: PWA conducts multiple safety studies from which potential projects are identified and assigned short, medium or long term priorities for inclusion in the CIP.

<u>Watershed Studies</u>: PWA conducts hydrologic and hydraulic studies within the multiple watersheds and flood control zones from which projects are identified and prioritized for inclusion in the CIP.

Project Timing, Budget, Funding and Expenditure Estimates

The CIP includes descriptions and cost estimates for each project, possible funding sources and estimated implementation timelines. By their nature, capital improvement projects can often take several years to complete with planning, design, funding and construction implemented in several phases. There are a number of unknowns and uncertainties when developing future plans in the current highly volatile economic environment. Forecasting future funding opportunities is extremely difficult. Estimating the cost of projects in future years is not an exact science and furthermore, priorities can change overtime. Therefore, the CIP should be seen as a planning document that is subject to change.

Public Works Projects are categorized into two groups, Flood Projects and Road Projects. There are ten flood control zones countywide with the following watershed boundaries:

Zone 2 – Serving the communities of Castro Valley, San Lorenzo, Ashland, Cherryland, and Fairview. Zone 2 encompasses 40,390 acres with 55 miles of creeks, including San Lorenzo and Cull Creeks.

Zone 2A – Includes the City of San Leandro (partial) with 329 acres of watershed.

Zone 3A – Serving the City of Fremont (partial) and Warm Springs with 19,700 acres of watershed and nine pump stations.



Zone 4 – Includes the cities of Hayward (partial) and the communities of Mohrland, and Russel City with 2,960 acres of watershed.

Zone 5 – Serving the cities of Fremont (partial), Newark (partial), Union City (partial), and the communities of Centerville, Niles, and Decoto. Zone 5 includes 45,440 acres of watershed, including the eight creeks and the Newark and Mowry slough.

Zone 6 – Serving the City of Fremont (partial) and the Warm Springs area (partial), and communities of Irvington and Mission San Jose. Zone 6 includes 10 creeks and the Lake Elizabeth Reservoir.

Zone 9 - Serving the City of San Leandro (partial) with 2,482 acres of watershed and four pump stations.

Zone 12 – Serving the Cities of Oakland, Emeryville, and San Leandro (partial), Zone 12 has a watershed area of 51,200 acres with 12 creeks spanning 18 miles, and five pump stations.

Zone 13 – Includes the City of San Leandro (partial) with 3,200 acres of watershed, including the San Leandro creek.

Within the Flood Program there are four categories of projects:

- 1. Flood Control Restoration Projects-These projects restore natural creek functions; provide for the passage of fish, restore creek ecosystems; and provide for improved water quality in our creeks and channels.
- 2. Major Flood Control Maintenance Projects-These projects restore the original design capacity of the existing system; repair failing portions of the system; extend the useful life of the system; and keep the system performing as planned.
- 3. Watershed/Special Studies-These studies identify areas of needed flood control improvements; analyze the impacts of new development on flood protection; identify areas where it may be possible to develop environmental restoration projects without compromising flood protection; and identify the impacts of continued sea level rise on the flood control channels that discharge into the bay.
- 4. Flood Control Capacity Improvement Projects-These projects increase the flood protection of the existing system; expand the system by building new flood protection facilities where the District had none before; and improve the operating efficiency of the existing system.

The Road Program is generally geographically restricted to the Unincorporated areas of the County. Most incorporated jurisdictions are responsible for their own road maintenance unless specifically contracted with the County. The Road Program has five major components:

- 1. Major Maintenance Program-projects in this category include major capital improvements needed on existing transportation infrastructure for the purpose of maintaining existing facilities. Typical projects include lifecycle extensions major risk reduction work as well as updating obsolete facility / infrastructure.
- 2. Pavement Management Program-projects in this category include pavement preventative maintenance treatments such as crack sealing, slurry seals, micro seals, and chip seals as well as road reconstruction treatments such as pavement overlays, full depth AC replacement and full depth reclamation (FDR). Street Saver®, a pavement management software, is used to monitor pavement conditions, and to prioritize resurfacing projects.
- 3. Transportation Infrastructure Safety Program-projects in this category include the preparation of infrastructure and safety studies and the implementation of improvements as recommended by said studies; the implementation of neighborhood traffic calming measures as developed using the County traffic calming program. Typical projects may include traffic signals, street lighting, street widening, guardrails, and traffic calming measures.
- 4. Pedestrian/Bicycle Facility Program-projects in this category include the implementation of improvements identified in the bicycle and pedestrian master plan, the safe routes to schools' study and the ADA transition plan, including new sidewalks, curb ramps, crosswalks, pedestrian beacons, bike routes and bike lanes.
- 5. Major Infrastructure Improvement Program-These large-scale projects include bridge replacements, corridor improvements, utility infrastructure improvements, and safety improvements.



In the Capital Projects section, information about each project is presented. The following PWA managed projects, are also mentioned under the Tier One section of the CIP: Hesperian Boulevard Corridor Improvement Project (I-880 to A Street), Meekland Avenue Phase 2-Blossom to East Lewelling (BPMP), and Mission Boulevard Phase III. To manage these complex projects with multiple funding streams and to leverage the maximum amount of state or federal funding, PWA shifts eligible funding to the most appropriate project given the circumstances. Any difference in the original commitment amounts as compared to the project information sheets is due to interest earnings and PWA's assessment of the funding situation.

# Tier One Projects

As part of the Fiscal Year 2012-13 Budget adoption, the Board established policies regarding the property tax increment returned to the County due to the February 1, 2012, statewide dissolution of redevelopment agencies, including:

- Allocating up to \$18M annually for up to five years for Board-approved priority capital projects in Unincorporated County (Tier One Projects) to be completed by the Community Development Agency (CDA), General Services Agency, or the Public Works Agency (PWA);
- An annual review of all projects and proposed funding including consideration of projects in the unincorporated area; and
- Scheduling a Board work session to discuss additional policies and guidelines after the State Department of Finance has completed its final determination regarding property tax increment from former redevelopment agencies.

On July 29, 2014, the Board took action to clarify policy relating to Tier 1 projects including:

- Continuing to allocate up to \$90M previously approved by the Board for Tier 1 projects on a "Pay-As-You-Go" basis; and
- Extending the time for accrual of these funds past the original 5 years in order to complete the Tier 1 projects or reach the \$90M (whichever comes first).

On October 25, 2022, the Board reallocated funding from the Hillcrest Knolls project to the Law Enforcement Facility project. On November 22, 2022, the Board cancelled the San Lorenzo Civic Plaza project and added and reallocated the associated funding towards three new Tier One Projects, all to be managed by CDA:

- Lorenzo Theater rehabilitation and reuse (\$2,300,000)
- Hayward Acres Family Resource Center (\$750,000)
- San Lorenzo Commercial Kitchen (\$1,350,000)

On June 3, 2025, the Board considered the reallocation of the San Lorenzo Commercial Kitchen funds to the San Lorenzo Theater rehabilitation project. The reallocation of these funds is shown in the FY 26-30 CIP but is subject to formal board approval.

Due to funding eligibility rules in leveraging the maximum amount of State funding, PWA consolidated Tier One funding to Mission Blvd Phase 3. Additionally, the Hesperian Blvd Streetscape and Meekland Ave Phase 2-Blossom to East Lewelling projects were completed without using Tier 1 funds.

As of the publication of this document, seven Tier One Projects have been completed, two are in process, one is pending Board approval and one has not started. Of the \$90 million allocation, \$72 million has been spent or encumbered, \$5 million reallocated to non-Tier One projects, and approximately \$13 million is pending reallocation potentially to White Cotton Cottage.

The CIP forecasts approximately \$9.65 million in funding being used in FY 26-30 associated with Lorenzo Theater Rehabilitation and Law Enforcement Facility. Please see Capital Projects section for more information.

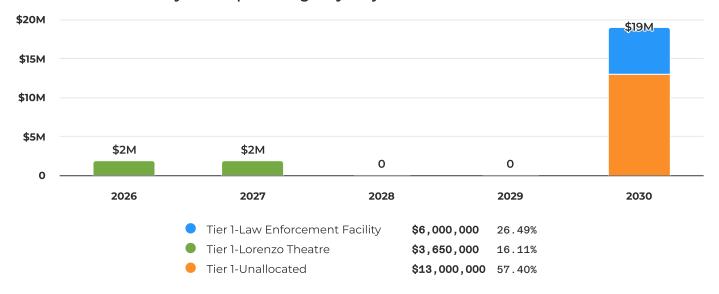

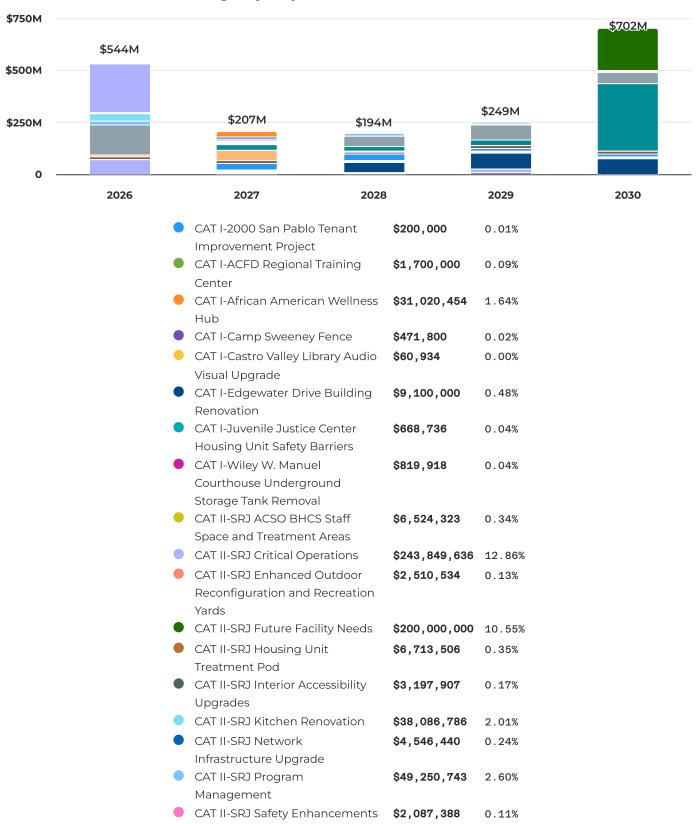

On February 28,2023, the Board authorized (Item No. 102) an amendment to the Task Order with SKA for additional design services.

On March 12, 2024, the Board amended (File No. 31189, Item No. 28) the Fiscal Year 2024 – 2028 CIP to increase the project budget from \$5,652,896 to \$5,753,925 (\$101,029 increase) for additional construction costs and authorized the award of a construction contract to ADC Construction.

The County is constructing a new facility for the Fire Department to provide training for new cadets, state certification for fire personnel, live-fire training simulation, urban rescue, hazardous material response, confined space training, and emergency vehicle operation training. The new training facility will be located on County-owned property at 5053 Gleason Drive in Dublin adjacent to the existing Fire Station 17, East County Hall of Justice, the Alameda County Office of Emergency Services, Santa Rita Jail, and several other public safety facilities in the area.

The facility will consist of two structures: a classroom building and a training tower. The single-story, approximately 8,000 square foot classroom building will provide classrooms, offices, storage, and exercise facilities. The five-story, approximately 5,550 square foot training tower building will include simulation rooms for smoke and burning scenarios, equipment storage, and a training control room. In addition, approximately 43 parking spaces will be available.

On March 31, 2020, the Board amended (Item No. 3.4) the Fiscal Year 2019 - 2024 Capital Improvement Plan (CIP) to add the ACFD Regional Training Facility Project (Project) to Category IV - Pending Projects Studies Underway and approved the use of the East County Development/Infrastructure Improvement Funds to support Capital Investments for the Project in an amount not to exceed \$20,000,000.

On July 28, 2020, the Board amended (File No. 30497, Item No. 74) the Fiscal Year 2020 - 2025 CIP to transfer the Project to Category I - Projects Approved and Underway, with a project budget of \$2,287,500.

On April 6, 2021, the Board approved (Item No. 47) a fund transfer from ACFD to the Project in the amount of \$1,712,500, and authorized ACFD to reallocate Project funding in the amount of \$6,000,000 into ACFD's proposed Fiscal Year 2021 - 2022 budget, increasing the Project budget to \$30,000,000.

On May 4, 2021, the Board amended (Item No. 30) the Fiscal Year 2020 - 2025 CIP to increase the budget for the Project from \$30,000,000 to \$30,056,880 (\$56,880 increase).

The African American Wellness Hub will serve as a focal point designed to preserve and actualize the core understanding and best practices of African American people with a focus on wellness.

The General Services Agency (GSA) and the Alameda County Health (ACH) Agency are working together to advance the project in alignment with community input. At the same time, GSA is collaborating with Vanir Construction Management, Inc. to develop a Request for Qualifications (RFQ) for a Progressive Design Build Entity, which will design and construct the project. The advertisement for this RFQ is expected to be published in Spring 2025, and GSA anticipates obtaining Board approval for the chosen Progressive Design Build entity in Fall 2025 and has an estimated cost of roughly \$31 million.

On June 27, 2023, the Board authorized (File No. 31044, Item No. 43) the President of the Board to sign the Real Property Purchase and Sales Agreement to purchase the property at 1918 Martin Luther King Jr. Way, Oakland for a purchase price of \$4,700,000, which included closing costs of approximately \$200,000. The Board also authorized the Director of the General Services Agency (GSA) to approve and accept the purchase and acquisition of the property, including execution of the escrow documents and accept the deed conveying title; and the use of the Mental Health Services Act fund to pay for the purchase of the property and transfer \$4,700,000 to the General Services Agency Capital Fund.

On August 1, 2023, the Board adopted (Item No. 89.2) the Alameda County Fiscal Year 2023-2024 through Fiscal Year 2027-2028 Capital Improvement Plan. The African American Wellness Hub was included and is identified as a Category I GSA Project Approved and Underway.

On February 23, 2021, the Board approved three-year contracts with five vendors, including Vanir Construction Management, Inc., to provide the Alameda County General Services Agency with as-needed project management and contract management (PM/CM) services. Each contract is valued at \$2,000,000.

On January 23, 2024, the Board authorized Amendment No. 1 to extend the contract for as-needed PM/CM services with Vanir Construction Management, Inc. This amendment extends the contract period from February 23, 2021, to February 22, 2024, further extending it through February 22, 2026.

On September 17, 2024, the Board approved Amendment No. 2 to the contract with Vanir Construction Management, Inc. This amendment extends the previous contract term from February 23, 2021, to February 22, 2026, through February 22, 2028. It also increases the contract amount by \$1,866,861, bringing the total value to \$3,866,861.

Phase II, which will be led by GSA-Capital Programs, will address the balance of capital improvements required to support full programmatic occupancy by the Alameda County Probation Department. This work includes removal of existing improvements in the first-floor suites recently vacated by the prior tenant and a complete fit out, including new functional areas to accommodate programmatic requirements for Probation. Once complete, the facility will be open to serve Probation clients on-site.

The Santa Rita Jail Critical Operations Project (Project) will contribute to providing a safer and more reliable environment for the Santa Rita Jail operations. The General Services Agency (GSA), with the support of a third-party construction management firm, and in coordination with the Alameda County Sheriff's Office, has confirmed several critical infrastructure projects that will address safety and functional issues identified in the Facility Condition Assessments (FCA) for SRJ. This Project is the result of the FCA.

The Project will replace and upgrade key facility infrastructure to improve functionality, reliability, and safety at the estimated 980,000 gross square foot SRJ facility, which opened in 1989. The scope of work to be performed includes the following:

- Two 1500kVA 12KV generators will be replaced, and associated electrical system infrastructure upgrades will be made.
- A new one-million-gallon steel above-ground water tank will be installed, along with a second 12-inch water main for redundancy.
- The building management systems will be fully replaced, including Honeywell XC Classic controllers and FS-90 fire panels.
- Fire-life safety systems will be upgraded, including fire alarms, sprinklers, cybersecurity, telecom/low voltage, audio, and security radio systems. The security electronics system will be replaced with a new non-proprietary system to improve remote door control, intercom, building perimeter, duress system alarm monitoring, and CCTV surveillance.
- 123 commercial-grade doors will be replaced with detention-grade doors and hardware across several housing units (HU). Additionally, nine detention-grade sliding doors will be replaced in numerous areas within the facility.
- The HVAC (heating, ventilation, and air conditioning) system will undergo insulation removal and reapplication in fan enclosures of each HU and the core buildings, along with basic maintenance. Any unserviceable HVAC equipment or inaccessible ductwork will be replaced or cleaned as necessary.
- The interior Ring Road around the perimeter of the housing units, within the secure perimeter of the facility, will be replaced.
- The roofs of multiple housing units will be replaced with new insulation, roofing membranes, and flashings, and photovoltaic panels on one unit will be removed and reinstalled.

On April 30, 2024, the Board amended (Item No. 37, File No. 31227) the FY 24-28 CIP to increase the project budget from \$3,232,191 to \$10,464,691 and awarded a construction contract to CWS Construction Group, Incorporated.

In the FY 25-29 CIP, Category III Facility Conditions Assessment (FCA) costs totaled approximately \$841 million. This figure was developed by taking the direct construction costs from the 2018 FCA report and applying industry-standard markups for Design Contingency, Bonds and Insurance, General Conditions, General Requirements and Contractor Overhead and profit. In addition, the 2018 numbers were escalated to reflect current market conditions and reflect future capital costs using two construction indices. The figures in the FY 25-29 CIP did not include seismic retrofit costs nor the annual expense of daily routine maintenance, including preventative and corrective maintenance activities for County Facilities.

The FY 25-29 CIP methodology for the FCA portfolio is not being utilized for the development of the FY 26-30 CIP. Given GSA's progress and the development of the Facility Need Priority 1 Program, this project, Facility Conditions Assessment - Deferred Maintenance, represents the body of work that remains from the 2018 FCA report. The \$25 million estimate is an annual placeholder until GSA has additional information or cost estimates that it can present to the Board for new projects.

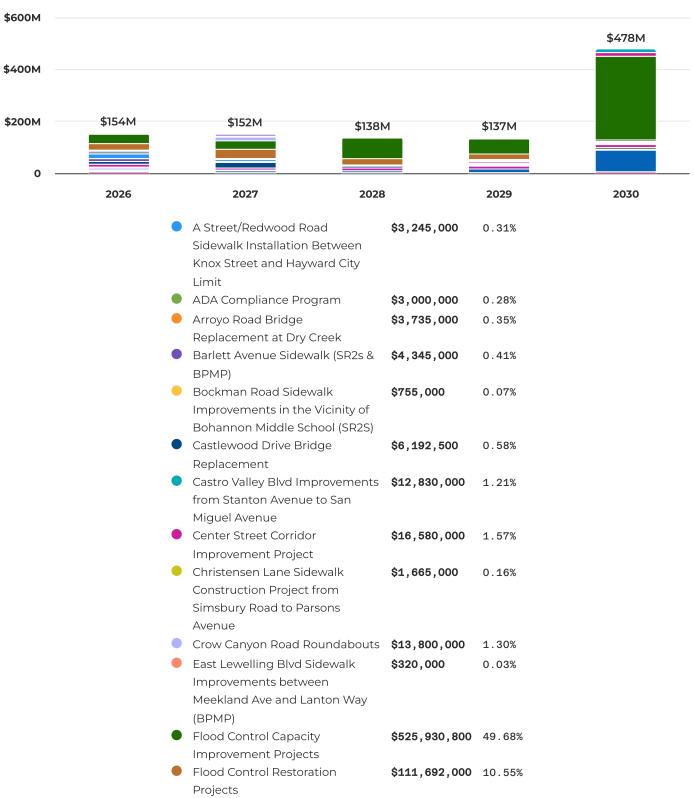

# Financial Policies

The County has a comprehensive compendium of financial policies that includes debt management, financial management and accounting policies. In October 2024, the County Administrator's Office and the County's elected Auditor-Controller's Office jointly provided the most recent updates to the financial management policy to follow the current industry best practice.

# Financial Management Policy

The goals of this policy:

- To deliver quality services efficiently and most cost-effectively of each tax dollar.
- To maintain a financial base sufficient to sustain an acceptable level of vital services to preserve the quality of life in Alameda County.
- To have the ability to withstand local and regional economic downturns and adjust changes in the service requirements of the County, and respond to changes in Federal and State priorities and funding as they affect the County's residents.
- To maintain the highest possible credit rating and reputation for prudent financial management to lower the closet of capital borrowings and to assure the County's taxpayers that County government is well managed and financially sound.

# **Investment Policy**

Pursuant to California State Government Code section 27133, the elected Treasurer-Tax Collector must submit an annual investment policy renewal to the Board. The policy provides guidelines for the investment of monies in the Treasurer's cash and monies in the investment pool. The Board of Supervisors annually delegates the responsibility for the stewardship of the County's investment Program. The Investment Policy applies to all funds over which the Treasurer has been delegated the fiduciary responsibility and direct control for its management. The main objectives for this policy include: Safety of principal, sufficient liquidity of the investment portfolio, and maximize investment income with the consideration of budgetary and economic cycles and the investment risk constraints.

# **Debt Management Policy**

To ensure inter-generational equity, there are capital projects that are financed by long-term debts. To ensure the County remains in good financial standing, the policy establish parameters and guidelines for the issuance of debt. The key objectives the Debt Policy helps to meet include:

- Maintain the financial stability of the County by encouraging sound decision-making, so that long-term financing commitments are affordable and do not create undue risk or burden.
- Provide guidelines for determining the appropriate use of debt financing to fund County projects, and to incorporate best practices into the County's issuance and administration of its indebtedness.
- Maintain a moderate debt burden.
- Maintain strong credit ratings and general market receptiveness to ensure efficient access to the capital markets and minimize the cost of capital.
- · Meet the requirements of state and federal law and regulation, including federal requirements regarding disclosure.
- Ensure that the County's debt is consistent with the County's planning goals and objectives and capital improvement program or budget, as applicable.

# Capital Improvement Policy



The County's Capital Improvement Policy was established in 2001. This policy helped to shape the direction and criteria when the five-year Capital Improvement Plan (CIP) is being compiled. The CIP is updated annually, and projects with a budget in the upcoming fiscal year are included in the total appropriation. A capital improvement is defined as physical betterment or project involving facilities, land, or equipment and the useful life of the structure should be prolonged for at least 10 years at a cost of \$100,000 or more. Below is the County's Capital Improvement Policy.

#### I. Definition of Capital Improvement

A capital improvement is a physical betterment or project involving facilities, land, or equipment, with a substantial useful life of at least 10 years, and a cost of \$100,000 or more. Items classified as capital improvements include:

- New buildings (including equipment needed to furnish such buildings);
- Alterations, additions or improvements to existing buildings;
- Land improvements, acquisition, and development;
- Equipment purchases with a total cost of \$100,000 or more and a useful life of at least 10 years; or,
- Long-range planning and feasibility studies required before any of the preceding public facility improvements, or equipment purchases can be undertaken.

#### II. Capital Improvement and Equipment Support Program Policies

Capital projects will be undertaken in order to address documented needs and/or demands of the County. The Capital Improvement Program will be a realistic five-year plan of capital spending, based on revenues and other financial resources which may be reasonably anticipated over the term of the plan. All capital project proposals will be thoroughly evaluated in terms of their estimated impact on the annual operating budget of the County. The County will maintain its existing capital investments to minimize future maintenance and replacement costs.

The allocation of capital improvement funding will take into consideration the order of priority criteria outlined below:

- 1. Enhance protection of public health and/or safety;
- 2. Ensure compliance with state and/or federal law or administrative regulations;
- 3. Reduce and/or stabilize operating budget costs;
- 4. Prolong the functional life of a capital asset of the County by 10 years or more;
- 5. Improve the ability of the County to deliver services.

#### III. Purpose of the Capital Improvement Program

The purpose of the Capital Improvement Program is to identify the County's capital needs and to provide a method through which the County takes a planned and programmed approach to utilizing its financial resources in the most responsive and efficient manner to meet its service and facility requirements. The capital planning process is developed to achieve the following results:

- Consolidation and coordination of all agency/department requests with the goal of reducing unnecessary delays;
- Establishment of a system of procedures and priorities by which each proposal can be evaluated in terms of public need, the interrelationship of projects, and cost requirements;

#### IV. Capital Improvement Budget Policies

- The County will develop a five-year plan for capital improvement and update it annually;
- The County will adopt an annual Capital Improvement Budget based on a multi-year plan;
- The County will coordinate the development of the Capital Improvement Budget with the development of the annual operating budget;
- The County will use intergovernmental assistance (i.e., State, federal, redevelopment agencies) to finance only those capital improvements that are consistent with the Capital Improvement Program, County priorities, or documented



program needs, and whose operating and maintenance costs have been included in the operating budget forecasts;

- The County will make every effort to maintain all its assets at a level adequate to protect the County's capital investment, and to minimize future maintenance and replacement costs;
- The maintenance of existing assets is the County's primary capital expenditure consideration;
- The County will identify the estimated costs and potential funding sources for each capital improvement before it is submitted for approval;
- The County will determine the least costly financing method for all new projects;
- Project requests will be reviewed and priorities analyzed by the County Administrator's Office and the General Services Agency;
- The Capital Improvement Budget will be adopted and incorporated in the County's Annual Budget.
- The County, through the General Services Agency, will establish ongoing monitoring and oversight functions for each approved project to ensure that each one is completed on time and within the approved budget.
- The County will make every effort to include local vendors as part of any capital project contract award.
- The County will, when siting facilities and where feasible, consider and use smart growth criteria, including among other things: proximity of public transit service; availability and proximity of affordable housing; pedestrian access and opportunities for mixed use development; sites within urban core areas; and the need for economic revitalization.

#### V. Steps in the Development of the Capital Improvement Program

The development of the capital improvement program includes the following steps:

- Establish administrative policies and a framework for capital programming and budgeting. All requests for capital improvement projects are submitted to the County Administrator's Office, Finance Director, for review and consultation with the General Services Agency. These requests may be submitted at anytime during the fiscal year between July 1 and December 31.
- **Prepare a complete inventory of existing facilities.** The General Services Agency will prepare an inventory of all existing County owned and leased facilities. The inventory will be used to identify the eventual need for rehabilitation, renovation, replacement, expansion or retirement of County-owned facilities.
- Report the status of previously approved projects. The report will be used to inform the Board of Supervisors of the status of each approved project and will include the estimated cost and funding resources needed to finance its completion. Monitoring and oversight functions will be established for each approved project to ensure that the each one is completed on time and within the approved budget.
- Perform financial analysis and financial programming. Financial analysis will be used to determine the County's financial capability for major expenditures by examining past, present and future revenue, expenditures and debt. The selection and scheduling of funding resources is financial programming. The objective is to set capital expenditures at a level that the County can safely afford over multiple years while maintaining a minimal impact on other County revenues. Some other important objectives include:
  - maintain a prudent balance of debt service to current expenditures;
  - determine debt capacity and appropriate debt service levels;
  - maximize use of intergovernmental aid relative to local expenditures;
  - maintain or upgrade of the County's credit rating to minimize the cost of funds.
- Compile and evaluate project requests. Beginning in FY 2001-02, requests will be received by the County Administrator's Office, Finance Director between July 1 and Dec 31 of each fiscal year for consideration and inclusion in the Capital Improvement Plan and/or Capital Projects Budget for the following fiscal year. They will be reviewed, evaluated and summarized in consultation with the General Services Agency. The County Administrator, and the Director, General Services Agency, and other appointees and representatives, will review and prioritize each project based on the Board of Supervisors approved criteria outlined under the Capital Improvement Program Policies section.
- Adoption of the Capital Improvement Plan and Budget. The County Administrator will present the annual Capital Improvement Plan and Budget to the Board of Supervisors for its consideration, modification and adoption.



• Monitoring the Capital Improvement Plan and Budget. The General Services Agency, in coordination with the County Administrator's Office, is responsible for the implementation of the Capital Improvement Budget. The County Administrator's Office is responsible for the monitoring and reporting to the Board of Supervisors on the implementation of the Capital Improvement Plan.

# Long Range Capital Financing Plan

On August 1, 2023 the Board of Supervisors approved the Long Range Capital Financing Plan and the establishment of a Special Capital Construction Fund to cover the unfunded needs of the GSA capital portfolio. A copy of this policy can be found in this linked document: CAO\_355205.pdf

# Alameda County Owned and Leased Excess Property Inventory

#### September 2025

#### **Government Code section 50569**

On or before December 31 of each year, each local agency as defined in CA Govt Code §50569 shall make an inventory of all lands held, owned or controlled by it or any of its departments, agencies or authorities to determine what land, including air rights, if any, is in excess of its foreseeable needs. A description of each parcel found to be so in excess of needs shall be made a matter of public record. Any citizen, limited dividend corporation, housing corporation or nonprofit corporation, shall upon request be provided with a list of said parcels without charge.

#### **County Owned Excess Properties:**

#### Broadway Complex: 400, 401, 430 Broadway; 480 4th Street; 499 5th Street, Oakland

The County is engaged with Related and East Bay Local Development Corporation via an Exclusive Negotiations Agreement to ground lease the properties for an affordable housing development project.

#### Arena Center Campus: 6775, 7001, 7195 Oakport Street, Oakland

The County acquired the Arena Center in September 2014, and the complex has been largely vacant with the exception of uses during COVID-19 for a community food distribution site and a warehouse for personal protective equipment distribution as well as use by the Registrar of Voters for training and vehicle parking during elections.

The General Services Agency (GSA) engaged with multiple departments on potential occupancy. Development and occupancy did not proceed due to several challenges, including but not limited to public transportation access concerns and cost considerations.

The Board declared the campus "surplus" by Resolution on August 6, 2019 (R-2019-321, File 30325, Item No. 25.3). Following approval from the State Housing and Community Development Department, an auction for sale was scheduled in October of 2023, but due to a significant downturn in the real estate market resulted in no offers received.

In 2024, two letters of interest were received from private developers for potential acquisition, but these did not materialize. Also in October 2024, GSA posted a Request for Interest for potential third-party lease(s) with no responses.

In August 2025, GSA posted a Request for Proposals for professional evaluation and consulting services to assess the highest and best use and potential development opportunities, with an anticipated contract start date in January 2026.

#### Malibu Parking Lot: 8000 South Coliseum Way, Oakland

The surplus Malibu property is jointly owned with the City of Oakland and is leased for short term parking as well as being used for Coliseum event overflow parking. The County's fifty percent undivided interest has been declared surplus, and the City of Oakland is in the process meeting the requirements to declare the City's fifty percent undivided interest as surplus as well.

#### Former Castro Valley Library: 20055 Redwood Road, Castro Valley

On May 9, 2024, the Board of Supervisors approved the Parks and Recreation Historic Commission's recommendation to place the property on the County's Register of Historic Resources. The property is also eligible for the California Register of Historic Resources due to the distinctive local example of Mid-Century Modern style architecture in the California context. The Community Development Agency will seek direction on disposition from the Board.

Glenn Dyer Jail: 550 – 6<sup>th</sup> Street, Oakland



The Sheriff's Office ceased Glenn Dyer Jail operations in June 2019 with only transport of defendants by the Sheriff's Office from Santa Rita Jail in Dublin to the adjacent Wiley M. Manuel Courthouse in Oakland, continuing to occur in the sally port. A February 2023 study concluded that a sale or ground lease of the property would be best achieved if the jail was demolished.

The Jail is attached to the Wiley M. Manuel Courthouse with shared utility infrastructure. As a first step in segregating the property from the Courthouse, engineering plans for segregating the utilities and a plan for transport of defendants is to be developed.

#### Station 7 Palomares Hills: 6901 Villareal Avenue, Castro Valley

The Alameda County Fire Department currently occupies Station 7, which is owned by the County. It is anticipated to be vacated in approximately two years following construction of a replacement station.

The Fire District was in the process of selling the station; however, in 2023, the Parks and Recreation Historic District requested that the sale be put on hold pending an assessment for historic significance.
