- **681** Adult clients utilized employment services
- **157** Youth were placed in paid internships throughout Alameda County and various cities

- **401** Adult clients were referred to SUD and Mental Health Services
- **542** Adult clients were active to CORE, our one-stop reentry center
- \$130K provided to Adult clients for stabilization services (food, household goods, transportation, etc.)
- **352** Justice involved youth referred to community based programs

• 54,479 Adult probation supervision contacts with 5,503 adult clients • 84% of Adult clients completed probation successfully • **1.47%** return to prison rate (including felony probation, MS & PRCS) • **1828** At-promise youth referred to prevention services

• **132** justice involved youth were referred to wraparound/intensive case management services, with a 41% successful completion rate • **65** youth received intensive cognitive behavior intervention services • Pretrial maintained a **98.5%** average Court hearing attendance rate • **389** unique clients participated in activities at CORE and collectively received 5,707 member services

• **350** At-promise youth successfully completed prevention services

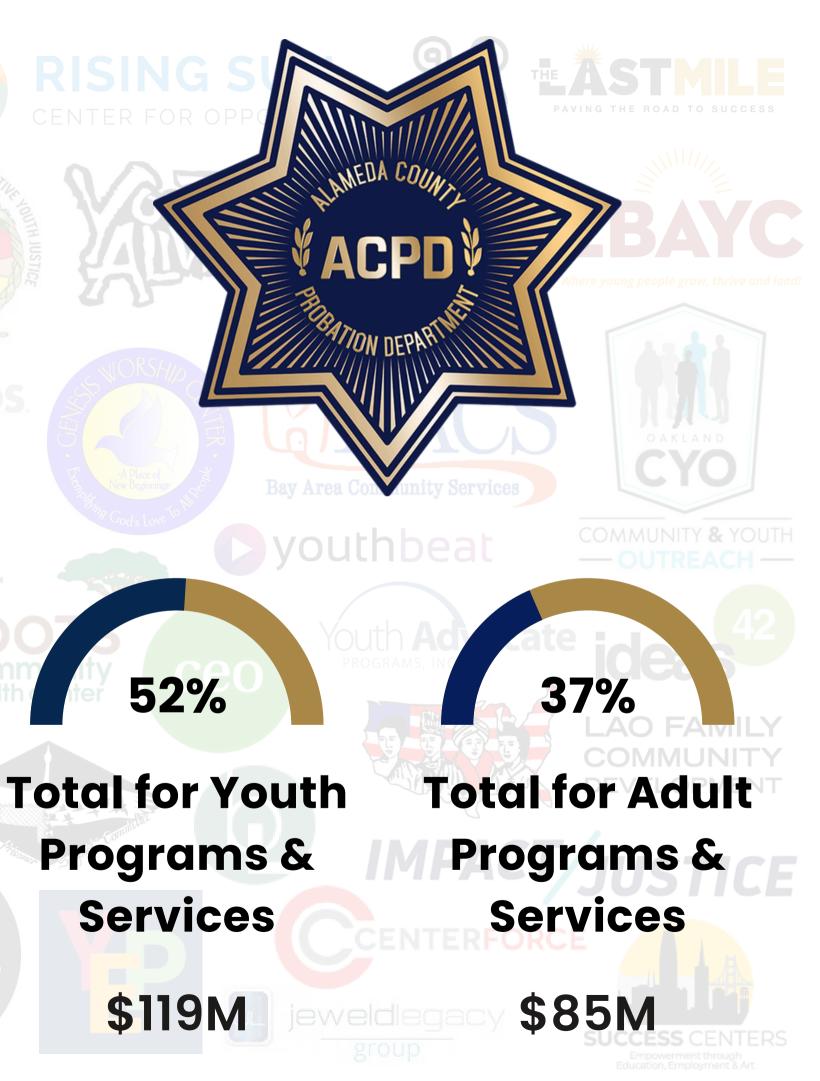
The proposed budgets highlight probation's vital role in public safety and prison reduction, but concerns remain around insufficient support for unfunded mandates.
